Reservation Information and Booking Policies

ePrivates are charged at the time of reservation. Bookings will be taken at the reduced prices until November 1, 2009. We recommend booking as soon as possible if you have requests for specific instructors.

- * ePrivates are non-refundable and will expire at the end of the season.
- * Booking dates for ePrivates should be between Dec. 19 and Apr. 4 (low season-same rates will be effective outside of those dates).
- * Minimum purchase of 3 lessons to receive the discounted rate on this booking form.
- * Additional days are NOT available for purchase during the season.
- * Lessons must be booked for specific dates. Reservations may be made through May 1, 2009.
- * Changes to reserved dates will be allowed with no fees, up until two weeks prior to the lesson dates.
- * If changes are made within two weeks, there is a \$100 re-booking fee.
- * Single person ePrivate lesson bookings are subject to an upgrade charge if originally booked as 1, but have 2-5.
 Upgrade All Day: Single Person to Multiple (2-5) person will be \$110
 Upgrade Half Day: Single Person to Multiple (2-5) person will be \$60
 Upgrade charges include a service fee of \$20/\$10 but still reflect a pre-season discount.
- * Multiple person privates are limited to a maximum of 5 per instructor.
 Another instructor booking will be required if you have more than 5 participants.
- * No call, No show for booked lessons (not changed prior to the lesson reservation date) are subject to forfeiture.
