Reservation Information and Booking Policies

ePrivates are charged at the time of reservation. Bookings will be taken at the reduced prices until November 1, 2011. We recommend booking as soon as possible if you have requests for specific instructors.

- A credit card and payment in full is required at the time of booking for all private lessons.
- Lessons must be booked for specific dates. Changes to these dates will be allowed with no fees up until two weeks prior to the lesson dates. If changes are made within two weeks, it may incur a re-booking fee.
All changes are subject to instructor availability.
- Minimum purchase of 3 lessons required to receive discounted rate.
- ePrivates are non-refundable and will expire at the end of the season.
- Additional days are NOT available for purchase during the season.
- Single person ePrivate lesson bookings are subject to an upgrade charge if originally booked as 1 person, but have 2-5 participate in the lesson.
- Multiple person privates are limited to a maximum of 5 per instructor. Another instructor booking will be required if you have more than 5 participants.
- No call, No show for booked lessons (not changed prior to the lesson reservation date) are subject to forfeiture.

**ACKNOWLEDGEMENT OF RISK & RELEASE
AND REQUEST TO PARTICIPATE IN A WINTER SPORTS ACTIVITY**

"I understand and acknowledge that skiing, snowboarding, and other alpine activities, including the use of lifts, involve many risks, dangers, and hazards, including, but not limited to changing weather and snow conditions; variations in terrain; grooming; ice; avalanches; deep snow; rocks; trees; streams; ditches; collisions with natural or man-made objects which may or may not be marked; collisions with other skiers; terrain features; exceeding ones skiing/riding ability; jumping; falling; slick or uneven walking surfaces; equipment failures and the possibility of becoming lost or separated from the class or instructor. I understand that snowmaking and grooming activities and equipment, and snowmobiles may be encountered at any time. I assume the risk of loading, riding and unloading the ski lifts. I recognize that falls and collisions occur and injuries are a common and ordinary occurrence of the activities. I have made a voluntary choice to participate in these activities despite the risks, dangers, and hazards that these activities present. I understand the philosophy of ski school is to increase your enjoyment by increasing your skill level. This may be accomplished by increasing the difficulty of terrain skied and instruction offered. In consideration of my being permitted to ski, snowboard, or participate in other alpine activities at Snowbird Resort, I expressly and unconditionally agree to assume **all risk of injury and death which might be associated with or result from my participation in these activities.**"

In consideration for the services provided by them, I release and agree to indemnify Snowbird Corporation, it's representatives, affiliates, officers, directors, agents and employees from any and all liability for any injury, damages or death whatsoever arising out of or in connection with participation in Snowbird Mountain School programs.

In consideration of my acceptance in Snowbird Mountain School programs, I also agree to indemnify and hold Snowbird Corporation harmless from any and all loss and expense including attorney fees and other legal expense incurred by reason of claims or liability for claims relating to participation in Snowbird's programs, regardless of whether such claims are alleged to have arisen in whole or in part due to negligence or any grounds of legal liability, including violation of any duty imposed by a statute, ordinance or regulation, on the part of Snowbird Corporation, it's representatives, agents, affiliates, officers, directors, and employees.
