**I understand and acknowledge** that snow skiing (including telemark) and snowboarding involve many natural and man-made **RISKS, DANGERS** and **HAZARDS**, including but not limited to changing weather, snow and light conditions, variations and steepness in terrain, terrain parks, impact with lift towers and other structures, cliffs, drop-offs, avalanches, snow immersion, obstacles including moguls, forest growth, bare spots, wildlife, rocks, debris and lift towers, equipment failures, collisions, incidents relating to chairlift loading, riding, and unloading, exceeding my own skiing ability, and the negligence of others. **I also understand and acknowledge** that I may encounter such risks, dangers and hazards at any time or place, and that serious **INJURY** or **DEATH** may result. **I further understand and acknowledge** that Snowbird is NOT a guarantor of my safety or the safety of my children, whether in mountain school or otherwise.

**In consideration** of me (or, if applicable, my minor child) being issued a Season Pass to ski and/or snowboard at Snowbird or oth-

erwise use Snowbird's facilities, I agree to **INDEMNIFY** (i.e. reimburse) Snowbird fully for any damages assessed against Snowbird and for any reasonable attorneys' fees, costs, and expenses incurred by Snowbird in its defense that result from any injuries or damages caused by me or by any child of mine, in whole or in part, to any other individual and/or any other individual's property.

**I also agree** that any legal action taken against Snowbird shall be filed in the Third Judicial District Court, Salt Lake County, State of Utah and enter into this agreement voluntarily and agree that it is binding upon me, my heirs, successors, assigns and legal representatives.

**I have been informed** of the terms, conditions and limitations pertaining to my pass (and/or that of my child), and I understand and accept them.

**I understand** a \$40 replacement fee is charged for lost or stolen passes. Fraudulent use of passes or violations of mountain policies may result in legal prosecution and/or loss of lift privileges with no compensation.

**I understand** that only my original pass may be used for lift access and that reproductions/copies of my pass are not permitted.

**I understand** that my pass must be presented to the ticket monitor outside of any pass holder.

**I understand** all policies regarding my season plan purchase and that Snowbird has a **NO-REFUND POLICY: once a season pass/ticket plan is purchased, no refunds will be given.** Credit for unused 2011/12 ski days on Daily Ticket Plans will not be extended after March 31, 2013. After this date all remaining credit will be lost.
